



Statement of Opposition to the Detailed Route

Please read carefully – Important information to know in completing this form

If you oppose the Detailed Route as described in the Notice that was filed by the company, you must complete a Statement of Opposition setting out the nature of your interest and the grounds for your opposition to the proposed detailed route. You have 30 calendar days to file your Statement of Opposition after being served with Notice or after Notice is published.

This form and any future documents you file with the Canada Energy Regulator (CER) will appear in the CER's online public registry, meaning that your personal information and the documents themselves can be accessed and viewed by the public.

The only matters to be considered in a detailed route process are:

- a) the best possible detailed route of the pipeline;
- b) the most appropriate methods of construction of the pipeline; and
- c) the most appropriate timing of construction of the pipeline.

It is important that you provide information in your Statement of Opposition that relates to these matters. For matters related to compensation, parties may apply to the Commission to determine compensation disputes. The CER's [Guidance on Land Related Compensation Disputes](#) provides further information about when compensation may be available.

Upon receiving and reviewing your Statement of Opposition, the Commission will contact you with respect to the details of any public hearing that may be held.

This form can be completed electronically or you can print a copy of the form and complete it legibly in writing. See Part F of this form for contact information if you need help with this Form and instructions on how to file your completed form.

* PPBoR, or Plan, Profile, and Book of Reference, is made up of two documents. The Plan and Profile is a drawing of the pipeline as seen from above (aerial view) and from the side (profile view) showing the exact proposed location of the pipeline. The Book of Reference identifies the lands, provides the names of the owners and occupants of the land, and shows the dimensions (length, width and total area) of the right-of-way required for the pipeline.

1. The preferred method for filing your form is online through the CER's e-filing tool (<https://apps.cer-rec.gc.ca/efile/ElectronicDocumentSubmission.aspx>). Step-by-step instructions are provided in the e-filing tool itself. Documents filed through the e-filing tool must be in PDF format.

Once a filing is made through the e-filing tool, you will receive a filing receipt via email with instructions regarding providing the CER with a signed copy of your receipt and form.
